III. THE INTERNAL EVIDENCE FOR THE TRINITY IN 1 JOHN 5:7-8

In addition to the external evidences in the Greek, Latin, and other languages for 1 John 5:7-8, there is some internal evidence as well. Let me print out once again 1 John 5:7-8 and show the 24 English words that have been eliminated in the heretical Gnostic Critical Greek Text, so you can see how the internal evidence bears on the doctrine of the Trinity in these verses.

1 John 5:7-8

"For there are three that bear record . . . [in heaven, the Father, the Word, and the Holy Ghost: and these three are one. And there are three that bear witness in earth,] . . . the Spirit, and the water, and the blood: and these three agree in one."

Notice that the heretical Gnostic Critical Greek Text takes away the 24 words in brackets that follow "that bear record." Their false rendering would then be:

"For there are three that bear record [a Greek <u>masculine</u> article, numeral, and participle] . . . the Spirit [a <u>neuter</u> noun], and the water [a Greek <u>neuter</u> noun], and the blood [a Greek <u>neuter</u> noun]: and these three agree in one."

If this were the case, and most definitely it is not, you would have a Greek <u>MASCULINE</u> participle agreeing with three Greek <u>NEUTER</u> nouns. That is a grammatical impossibility. If the Greek words in this false heretical Gnostic Critical Text were, in fact, used by the Apostle John, he would have used a Greek <u>NEUTER</u> <u>PARTICIPLE</u> rather than a Greek <u>MASCULINE PARTICIPLE</u> to go along with these three Greek <u>NEUTER</u> nouns. Since John did not do that, this proves conclusively that all 24 of these English words (and all 25 of these Greek Words) must be included in 1 John 5:7-8 in order to be absolutely grammatically correct! (See Dr. Moorman's article on these verses, p. 116)

Robert Dabney, in his article, "Dabney's Discussions Evangelical and Theological," reprinted by the Trinitarian Bible Society wrote:

"The masculine article, numeral and participle HOI TREIS MARTUROUNTES, are made to agree directly with three neuters, an insuperable and very bald grammatical difficulty. . ." (Dr. Moorman's article, p. 117)

This is very important grammatical evidence from the rules of Greek grammar.

I WAS SICK AS A CHILD!

(Continued From Last Month) PEOPLE WERE CALLED "CRIPPLED"

If you remember I was telling you, in the last BFTUPDATE (December/2014), that I was a sick child with tuberculosis of the bone which settled in my left hip. I was a patient in RAINBOW HOSPITAL FOR POOR AND CRIPPLED CHILDREN FOR THREE YEARS. When I was a child, this children's hospital was near Cleveland, Ohio-on the East side. The beautiful large cottage that housed many, many crippled children has been torn down since I lived there. (It is now a part of the Cleveland Clinic.) "When were you last there?" you ask. Let me tell you.

"VONNIE, IS THERE ANY PLACE YOU'D LIKE TO GO?"

One summer, when my husband took graduate work at the University of Michigan, I stayed with my in-laws at their Beach Street house in Berea, Ohio. I was a young mother, then One day, my mother-in-law asked me, "Vonnie, is there any place you would like to go? If so, I would like to take you there." Without hesitation, I replied, RAINBOW HOSPITAL!

SHE TOOK ME TO RAINBOW HOSPITAL

So, one hot summer afternoon (before there was air conditioning), my dear mother-in-law took me to RAINBOW HOSPITAL in South Euclid, Ohio. A strange feeling came over me as we walked into that cottage. As we entered, I noticed a room to my left. It was the business office. A woman greeted me. I said, "When I was a child, I lived in Rainbow Hospital for three years. Could I look around to remember my life then?" To my amazement that woman called me by my name, VONNIE, and spoke to me like an old friend. It had been years since she had seen me-perhaps twenty years-and she knew me!

NO MATTER THE NAME, WE WERE "CRIPPLED" CHILDREN

At the time, we sick children at RAINBOW were called *crippled*. That word does not bother me for that was what I was-- crippled. But, I still wonder at the rudeness of some children and adults, too, who stare, point fingers, and laughingly whisper behind our backs. Today that is a "No No" definition of us children's plight-but no matter what name we were called, we were *crippled* by disease and distress. Just because there is a more acceptable name given to a condition does not lesson the disease, or the harmed physical and/or mental condition of the person who is ill, or deformed. Nor does it lessen the emotional injury of the sick and different one who must bear the stares and finger pointing, by the curious who walk by.

RECENTLY, I DISCOVERED A DIARY WRITTEN in 1926-1930 BY MY MOTHER, GERTRUDE SANBORN, WHERE MY NAME WAS FIRST MENTIONED

Mother wrote: "We left Florida, June 7, 1926. After 3 & 3/4 days of steady traveling, we arrived in Cleveland. We had driven 1,200 miles, camped every night, and bought our meals. We certainly enjoyed our trip! The first day of travel, we drove from Jacksonville, Florida, to Atlanta, Georgia, and there we camped. The next day we camped in Tennessee near the Cumberland Gap. We had a wonderful trip-one that will never be forgotten. The scenery was beautiful. After the third night's camping at Springfield, Ohio, we had five flat tires—the only bad mark of the trip. The nearer we got to home, the farther away it seemed. We got to Ma's about four o'clock, and drove the car up in front of the house and tooted the horn. Ma was on the porch. She nearly went through the ceiling when she saw us. I brought Vonnie back with me, but it was still MY secret...." (THE FIRST MENTION OF ME IN THE DIARY.)

VAGUE MEMORIES OF DR. HARBIN'S OFFICE

As I was reading my mother's diary for January 1, 1926--January 1, 1930. I noticed the first mention of my having a physical problem not common to most three-year-olds. I don't remember seeing this DIARY before. It is most informative. I do not remember any of this pain. Have vague memories of being in Dr. Harbin's office. He had me pick up pennies off the floor. (NOT SURE IT WAS BEFORE OR AFTER MY HOSPITALIZATION AT RAINBOW.) I do remember crying and not being able to get out of bed those early days because of my confinement from my illness. I knew I had TB of the bone but I did not know I showed human T. B. infections, too. AT AGE THREE, I WAS HOSPITALIZED THREE YEARS IN RAINBOW HOSPITAL -A HOSPITAL FOR POOR & CRIPPLED CHILDREN. Yes, I was one!

ENTRIES FROM GERTRUDE SANBORN'S DIARY (1926-1930)

OCTOBER 2, 1929

Yvonne has been troubled with RHEUMATISM. I think I will take her to Dr. Dean some night this week.

MAY & JUNE. 1929

Yvonne had influenza, tonsilitis & measles. She was a very sick baby but Dr. Dean pulled her around.

DECEMBER 18, 1929

Yvonne had a sick spell of some kind. I called the doctor and he said she had bronchitis

FEBRUARY 5, 1930

Yvonne will be three years old. I just can't believe it. She is such a big girl, too.

Took Yvonne to have her legs exrayed because she limped all he time. We have a sun ray lamp and we use it on

Vonnie all the time and it certainly is helping her. She had rheumatism since before Thanksgiving.

MARCH 3,1930

Yvonne weighs forty pounds. She is so sweet.

We love her so much. She complains of her left knee.

She cries out in the night so many times. It's her leg.

I rub it every day.

JUNE 17, 1930

Yvonne complained so and her leg hurts her so very much.

She can hardly drag around some days.

Her back hurts her.

Took her to Dr. Dean again.

He says he doesn't know what the trouble is.

We asked him to recommend a specialist.

We tried to make an appointment with Dr. Harbin,

But he was out of town over the week end.

JUNE 23, 1930

Took Yvonne to Dr. Harbin, <u>an orthopedic specialist</u> at Lakeside Hospital. He examined her and we must come in the morning for X-rays.

JUNE 24, 1930

Took our Darling for an X Ray.

He says she has a T.B. hip.

We were simply stunned. We both cried like babies at the doctor's office.

He told us to bring her back to the Hospital at four o'clock. We did, and left our darling baby for treatment for two days.

They gave her a T.B. test.

She shows infection from Bovine & human T.B. germs.

JUNE 26, 1930

We took our angel baby out to RAINBOW HOSPITAL to lie for three years.

Oh, I can't believe it. This can't be so! Why should this happen to our lamb?

Bud & I are crushed.

I had to leave her in the office.

I couldn't even go in to say "BYE-BYE."

She cried so.

"GOD BLESS MY BABY!"

Everyone is stunned to hear about Yvonne!

Oh, How can I do without her?

I can't stand it around here.

Oh Dear, Oh dear!

JUNE 28, 1930

Yesterday we took the pretty dress and underwear and pajamas (that we bought Monday) back to the store She can't wear them. I can't even wash her clothes, in fact.

My honey is gone, and with her everything I had to do.

We went to see her this A.M.

We couldn't touch her or kiss her, though,

She has to stay in isolation for three days.

She doesn't sleep well.

Rainbow is a pretty place.

Yvonne has to lie flat on her back on a frame of metal.

They are going to put traction on her leg.

That is ropes and weights and pull it slowly out of the hip socket.

My poor little girl.

Why should she suffer so?

She cries so pitifully when she has to bid us goodbye.

The nurses say she's getting along all right, though.

So, I guess we'll just have to get used to it.

So, I guess we'll just have to get used to loneliness.

FRIDAY, JULY 5, 1930

Went out to the Barker reunion to Aunt Ruth's.

We didn't have a nice time.

Everyone is sad thinking of Yvonne-- -Aunt Ethel and Aunt Mary, and so on.

The doctor told us Aunt Mary had six months to live--cancer growing again!

Cleaned Yvonne's room.

Put away all her toys and put them up in the attic.

Next to Yvonne herself, I love her belongings.

I miss her sweet face and sunny smile.

I can't believe she's not here.

I just can't!!

I'm thankful I still have her, though.

It would be awful to be without her at all.

SATURDAY, JULY 6, 1930

Saw my Honey today. She looks fine, but still lonesome.

SUNDAY, JULY 7, 1930

Went to Gramma Van's. Everyone so solicitous about Vonnie.

MONDAY, July 8, 1930

Mama's birthday (47)

WEDNESDAY

Went to see our girlie.

She looks fine. All tan and rosy. Eats well and rests well.

I hope she is okay soon.

I pray so earnestly that it won't be too long for her baby sake.

SATURDAY, JULY 13, 1930

We took Mother out to Warrenesville and went to see Yvonne.

She was so glad to see us. She hugged us so tight.

She looked good all tan and healthy looking.

Yvonne said she was tired of lying on "this frame."

Poor kid!

I hate to think of her lying out there flat on her back!

We ate dinner out tonight.

SUNDAY, JULY 13, 1930

Went to church. Terrible hot! Ate dinner at "Ye Old Stage Coach Inn."

Lucille and Clayton came up this P.M.

After supper, they started to Youngstown.

Didn't seem like Sunday at all today. No evening service.

TUESDAY, JULY 15, 1930

Washed yesterday, Ironed today.

Aunt Minnie Van Tassel came to visit us this afternoon.

It was so cold yesterday. A bit warmer today though.

My baby has been gone three weeks today.

I miss her.

If only she did not have to lie on her back all day long. Florence has been ill (not her lungs). She and Elmer never meet.

He ditched her like an old shoe.

JULY 23, 1930

It has been terribly hot here—around 100 degrees.

I have felt the heat so, too.

Mr. Cotton, the Fuller Brush Executive, took Bud and me to the ball game

to see Indians defeat Yankees. 10-6.

Yvonne didn't cry today and she looks fine.

Oh, I hope it doesn't take her three years to get well.

JULY 24, 1930

I MISS HER SO MUCH! MORE EVERY DAY!

Bless her dear little heart!

She's been out to Rainbow four long weeks today!

Went to Ma's today. Had a nice time.

Ma has a pain in her left leg. Hope it gets better.

Pa is still selling brushes and dong not so well.

Business is pretty tough

JULY 25, 1930

TERRIBLY HOT! 98 DEGREES!

JULY 26, 1930

SATURDAY-WENT TO SEE OUR BABY.

She looked so sweet and pretty today--Poor little lonesome kid.

July 27. 1930

Sunday, terribly hot!
Lou and C. V. came from Youngstown.
MISS YVONNE SO MUCH!!
